
#### PROCEDURE

- Remove contents from box, verify if all parts listed are present and free from damage. Carefully read and understand all instructions before attempting installation.
  Failure to identify damage before installation could lead to a rejection of any claim.
- 2. Position the Door Cover Panel (1-2) onto the corresponding door of the vehicle.
- 3. Once the desired position is determined, mark the 8 holes of the Door Cover Panel (1-2) onto the door for drilling.
- 4. Using a 1/4" drill bit, drill out the marked holes. *Note: Do not drill through more than an inch to avoid damaging internal components in the door.* See Figure 1.
- 5. After drilling all of the holes, fasten the Door Cover Panel (1-2) using the provided Panel Fasteners (3). See Figure 2.
